



Thank you for taking the time to help us celebrate the best in local business at the 2021 Nova Awards, which will be held virtually on **Thursday, May 13, 2021**.

All businesses in the Timmins area are eligible for nomination; self-nominations are permitted and encouraged. Companies may only be nominated for up to two (2) categories, and a separate entry is required for each category. Nominees can only be finalists in one category. Judges will determine the most appropriate category. Nominees must be aware and willing to let the nomination stand.

Eligibility:

- Recipients of 2020 Nova Awards are ineligible for nomination in the same category for one year.
- Previous Nova Award finalists can be re-nominated in the same category or any other category.
- Non-profit organizations are only eligible for nomination for non-profit award or Indigenous partnership award.
- Sponsors and their employees are eligible for nominations in any category other than the one they are sponsoring.

Note: It only takes one nomination to be considered for a business excellence award. Nominations will be judged by their content and quality, rather than the number of nominations submitted on a business’ behalf.

An independent judging panel comprised of community representatives will select the award recipients as well as a maximum of three (3) finalists for each category. Finalists will be notified on March 2, 2021 and recipients for each category will be announced during the event on Thursday, May 13, 2021.
